The Blended Intensive Programme Living in Lisbon in an intensive and interdisciplinary course, which combines a short-term physical mobility component with an online component, in order to promote innovative ways of teaching and learning. It is coordinated by Iscte under the Erasmus + programme – and the parallel programme of the exhibition *Habitar Lisboa*, presented at Centro Cultural de Belém from 17 October 2023 to 28 April 2024, under a partnership with Iscte. The BIP Living in Lisbon offers the opportunity for students from three countries (Portugal, France and Germany) to participate in an intensive work week within an interdisciplinary and multicultural team.

# **Synopsis**



Many are the European capitals where house prices have been growing exponentially in recent years. Based on the specific case of Lisbon - where, since 2014, the price of housing in Portugal has been rising more than 6% per year, contaminating the surrounding municipalities and pushing their inhabitants out of the centre - this Blended Intensive Programme constitutes a space for reflection, contributing to the discussion on how architecture can add to solving this problem. Based on a critical reading of public housing policies that have been carried out in Lisbon over 50 years of democracy, supported with contributions from other disciplinary areas — Sociology, Geography, Landscape —, the aim is to produce a reflection that allows future hypotheses to be generated through the tools of Architecture, History and Criticism. In order to do so, students from the three universities involved — Iscte - Instituto Universitário de Lisboa, École Nationale Supérieure d'Architecture de Normandie and Goethe-Universität Frankfurt — will take part in a series of activities, including visits to the city, to residential buildings and to the homonymous Living in Lisbon exhibition (displayed in Belém Cultural Centre in partnership with Iscte), lectures by Sandra Marques Pereira, Gonçalo Antues, Tim Benton and as well as a lecture and final review by the internationally renowned architect in housing field Kamiel Klasse.

### Assessment

Assessment will be periodic and will be carried out in three moments:

- (1) Oral presentation of a piece of historical research carried out in groups, on a specific case study (in Portugal, France, Germany, Austria or Switzerland) -- 20% (carried out in groups)
- (2) Audiovisual presentation (3 minutes video) of a of research, putting forward a hypothesis and defending a thesis that contributes to solving the problem of housing in Lisbon -- 60% (carried out in groups)
- (3) Delivery of a review (250 words maximum) on the Blended Intensive Programme -- 20% (carried out individually).

The classification will be individual and expressed through a numerical scale from 0 (zero) to 20 (twenty) whole values, and will result from the weighted average of the three moments of assessment. The approval in the curricular unit and the obtaining of the ECTS credits depends on a classification equal or superior to 10. The assessment aims to verify the degree of compliance with the objectives

of the course unit concerning the acquisition of knowledge, its understanding and application, the acquisition of skills, critical thinking and decision-making capacity, organisation and work methodology.

The housing problem trajectory in Portugal: specificities and common aspects in the international context Sandra Marques Pereira, DINÂMIA'CET Iscte

In the second half of the 20th century, a time dominated by the welfare state model of society, comparative analyses of Portugal were always based on its negative divergence from most other countries. Today, Portugal's situation is often compared with the international context, often frozen in time, as if the welfare state, particularly in terms of housing, remained as intact in these "more developed" countries as it was in the post-war years or even in the 1970s. But that's not the case: the welfare state began to retreat progressively from the 1980s until the "final blow", the financial crisis of 2008. The divergence that previously characterized the analysis should be replaced by an approach that, while not neglecting an understanding of the specificities (inherited from the past or more recent) of Portugal and Lisbon in particular, focuses on the points of convergence, namely: 1. The growing revisualization of public

housing provision systems; 2. The increase in homeownership to the detriment of renting and the reversal of this trend in the post-crisis period (2008/ 2011-2014); 3. the re-emergence of housing as a central issue in the social, political and academic debate since 2016/2017; 4.the recent recovery of the role of the state (central and local) in the attempt to address (more or less urgently) the so-called global urban housing affordability crisis (Wetzstein, 2017). This presentation will begin with a brief discussion of the national housing trajectory. This will be followed by a characterization of the global housing crisis, without neglecting its national and local specificities. And it will end with a reflection on the social and political reactions to this crisis (essentially in the Portuguese context). Iscte, Building 2, Auditorium B203

Chelas is no longer Chelas. Is it? The visit to the Lóios neighbourhood, [formerly 'Zone N2' of the Chelas Urbanisation Plan], will begin at the Pink Panther, a nickname already registered with SIPA (Information System for Architectural Heritage) and continue through old farms, new vegetable gardens and housing cooperatives, a territory designed to respond to a city ideal that we can question today. Streets, galleries and bridges make up the colossal complex designed and built between 1972 and 1979 by Gonçalo Byrne and António Reis Cabrita, influenced by other megastructures such as the Gallaratese by Aldo Rossi / Carlo Aymonino (1967 -1974) or Park Hill designed by Jack Lynn / Ivor Smith (1957 -1961). The appropriation of the inhabitants and the negotiation implicit in the use of collective spaces, along with the (re)qualification of the facilities, inform the visit to this system of blocks centred on a public square. According to Gonçalo Byrne, the Pink Panther rethinks 'city making', comprising an alternative to the urban solutions adopted in Chela's plan, having welcomed many of the inhabitants of the shanty town known as Quinta do Narigão. By questioning the current 'housing crisis', the visit serves to understand the role of architecture in the service of societal issues that have spatial implications.

Inauguration of the Living in Lisbon exhibition



Since 2014, the price of housing in Portugal has been increasing at more than 6% per year. At the origin of this phenomenon is a combination of two factors: on one hand, an exponential increase in tourist accommodation and foreign investment in the Portuguese real estate market (an escalation not even the Covid-19 pandemic was able to halt); on the other, a continued lack of investment in housing policies. In a country with only 2% of public housing, this crisis has spread to the middle class, and now affects the whole of society. Every Portuguese person is, or knows someone, affected: families on a waiting list, tenants about to be evicted, young people unable to access their first home. Lisbon was the municipality in the country most affected by this problem, infecting the surrounding districts and pushing their inhabitants out of the centre. To oppose this movement, the Portuguese Plano de Recuperação e Resiliência [Recovery and Resilience Plan] (PRR) has allocated 2.7 billion euros to tackle the housing crisis, in order to meet the needs, by 2026, of a total of 26,000 families. But what, in the end, could the role of architecture be in this operation?

### Kamiel Klaasse (NL Architects)

Although it had an optimistic start, a modern neighbourhood built in the 1960s on the outskirts of Amsterdam gradually became a failure. The renovation of the neighbourhood began in the 1990s with the demolition and replacement of the large housing blocks. However, one of the buildings, with 500 flats, was spared and turned into a Klusflat by the De Flat consortium. Its structural elements and communal spaces were renovated, leaving the flats unfinished (which were subsequently completed by the inhabitants themselves). This strategy made it possible to minimise the initial investment, creating a new paradigm. The project, winner of the Mies van der Rohe Prize in 2017 and represented in the Habitar Lisboa exhibition, is presented by one of its authors, Kamiel Klaasse, at his first conference in Portugal.

# C - LECTURERS, CRITICS AND TUTORS SHORT BIO

#### Ana Brandão

Ana Brandão is an Architect and Ph.D. in Public Space and Urban Regeneration (Universitat de Barcelona, 2015) with a thesis on uncertainty in urban planning and urban design, with a focus on adaptive and flexible approaches, awarded with an Honorable Mention in Metropoles Ciência Prize, 2016. She has research expertise in interdisciplinary work on the intersection of public space, urban design, and urban planning. Specifically, her research has focused on the design, development, and management of city processes and their impacts on urban design and public space. At present, she is a researcher at DINÂMIA'CET-Iscte developing work on where and how to redesign public spaces to deal with transition challenges in the extensive city. She participated in several research projects in these areas. Among them, she co-coordinated the "Public Space Service System" project, with the handbook "COMMON PLA-CES. Guide for the Assessment and Interpretation of public space" (2018) and the "Grand Projects" research on the impacts of the Expo'98 event. She has published several books and articles and presented papers at scientific meetings in these various fields. She lectured at the Technical Institute of Lisbon, in the Civil Engineer graduation (2011-2012), and the Architecture Integrated Master at Iscte (2021/22), and is engaged in several advanced training activities such as short courses, workshops, and supervision of postgraduate students. She also worked as an architect, in CCG Arquitectos developing projects for cultural facilities and schools (2009-2010).



Architectural historian, she is professor at the École nationale supérieure d'architecture de Normandie. Dr. Caroline Maniaque work focuses on cultural exchange and the circulation of ideas between the United States and Europe, and on the training of architects. She was a past fellow of the Canadian Centre for Architecture (she worked on the exhibition Sorry out of Gas). Interviewes she made were included in the exhibition Sorry out of Gas and are now in





the collection of the CCA (Steve Baer, Michael Reynold). Fellow of the Center for Advanced Study in the Visual Arts (National Gallery of Art, Washington, DC), she is the author of Le Corbusier et les maisons Jaoul (Parenthèses, 2006), Le Corbusier and the Maisons Jaoul (Princeton Architectural Press, 2009), She is also the author of French Encounters with the American Counterculture, Burlington, Ashgate, 2011; Go West! Des architectes au pays de la contre--culture, Marseille, Parenthèses, 2014; Whole Earth Field Guide, Cambridge, MA, MIT Press, 2016 (with M. Gaglio); L'aventure du Whole Earth Catalog, Paris, Effa, 2021 and was responsible for the collection of texts Les années 68 et la formation des architectes, Rouen, Points de vue, 2018. She co-edited Architecture 68. Panorama international des renouveaux pédagogiques, MétisPresse, 2020 (with an English version). She was co-curator of the exhibition, Mai 68. L'architecture aussi ! (Paris, Cité de l'architecture et du patrimoine, May-September 2018 (with E. Marantz et J.-L. Violeau.



### Carsten Ruhl

Carsten Ruhl is the spokesperson of the research cluster Architectures of Order (AO), a founding member of the Center for Critical Studies in Architecture (CCSA),

and Professor of Architectural History at Goethe University Frankfurt/Main, Germany. Before, he served as a Professor at Bauhaus University Weimar and Ruhr-Universität Bochum, Germany. Carsten studied Architecture, Art History, Philosophy and Historic Science, and since has focused on post 18th century History and Theory of Architecture. His research projects were funded by scholarships from the Gerda-Henkel-Foundation, the German Academic Exchange Service (DAAD), London, the Getty Research Institute (GRI), Los Angeles and the German Research Fund (DFG). Carsten recently published an essay on architectural criticism entitled "Kracauer's Architecture. The Ornamental Nature of the New Capitalist Order" (with a response by Philip Ursprung) in the CCSA Topics series (2022) and is currently preparing a book on the medial construction of architectural surfaces. Other important publications are "Death and Life of the Total Work of Art. Henry van de Velde and the legacy of a Modern concept" (Berlin, 2015) and "Magisches Denken -- Monumentale Form. Aldo Rossi und die Architektur des Bildes" (Tübingen/Berlin, 2013). Carsten is currently co-editing the upcoming publication "Bauhaus Clouds: Challenges to the Nebula of Architectural Histories and Archives", CCSA Topics (Weimar, 2023)

### Catarina Raposo

Co-founder in 2014 of BALDIOS Arquitetos Paisagistas, a collective organisation that brings together the work of its five partners either in collaboration or in interdisciplinary co-authorship, in research processes, landscape projects and competitions.Landscape architect from the Instituto Superior de Agronomia, where she was Assistant of Teresa Alfaiate (2004-2014) collaborated in research projects on Lisbon's green structure coordinated by Gonçalo Ribeiro Telles and Manuela Raposo Magalhães (1998-2001). Since 2021 she has been teaching at the University of Coimbra on the European Master's Degree in Architecture Landscape Archaeology, having also taught project at the University of Évora (2003-2004) and organised, in co-authorship with João Gomes da Silva, the Seminar: 'Landscape: Architecture and Instability', at UAL (2009-2010). She has been invited to give open lectures and participate in project review (ISCTE, USI-Mendrisio, UALg, ISA, FAUP, UAL, ESAD-IPL). Cultural/curatorial projects include the curatorship of the 10th edition of the Open-House Lisbon 'Os Caminhos da Água' in 2021, team member for the Application of Guarda's European Capital of Culture for 2027 coordinated by Pedro Gadanho, the curatorship, in 2007, in collaboration with Cláudia Taborda, of the exhibition Paisagem: 'Space, Ideology and Action' as part of the Lisbon Architecture Triennale, collaboration in the publication 'Portugal Património' by Álvaro Almeida and Duarte Belo, and joining the editorial group of the AP magazine of the Portuguese Association of Landscape Architects between 2010-2013.

#### Daniela Ortiz dos Santos

Daniela Ortiz dos Santos is Assistant Professor in the Institute of Art History at the Goethe University Frankfurt and scientific coordinator of the Center for Critical Studies in Architecture. Her research, teaching, and curatorial activities on the intersection between transatlantic architectural history and historiography have been published in Portuguese, Spanish, French, English and German languages. She is the author of "Italian Roots in Latin American Architecture" (contribution to an anthology by Bloomsburry, 2022), "Anthropophagic Affairs" (LC Revue de recherches su Le Corbusier, 2021), "Invisible Files in Visible Institutions" (CRITI-QUE D'ART, 2020) and "Blaise Cendrars and Le Corbusier: villes et voyages utiles" (Komodo 21, 2018). She is co-editor of Contem-



porary Feminist Spatial Practices (ARCH+/Spector Books, 2023), Architectural criticism, medias and memory (Riobooks, forthcoming) and Bauhaus Clouds: Challenges to the Nebula of Architectural Histories and Archives (MBOOKS, forthcoming). Daniela was a fellow at the Fondation Le Corbusier in Paris and at the Canadian Center for Architecture in Montreal, and is currently a fellow at the Johanna Quandt Young Academy at Goethe in Frankfurt. She is trained in Architecture and Urbanism at the Federal University of Rio de Janeiro and holds a PhD in Architectural History and Theory from ETH Zurich.



### Eliana Sousa Santos

Eliana Sousa Santos is an architect, a researcher and an assistant professor of architecture. She was awarded the Fernando Távora Prize in 2017. She curated the exhibition The Shape of Plain held at Gulbenkian Museum and an associated project of the Lisbon Architecture Triennial 2016. She was a visiting postdoctoral research fellow at Yale University in 2013/14. She is currently working on the project "George Kubler's Shape of Time: The Historiographical effect of Portuguese Plain Architecture in Post- revolutionary Portugal". She has a degree in architecture from the Technical University of Lisbon, a master degree from University of Coimbra and a PhD from the University of London. #### Goncalo Antunes

Gonçalo Antunes is a Geographer. PhD in Geography and Territorial Planning, specializing in Territory and Development, by the Faculty of Social and Human Sciences of Universidade Nova de Lisboa (NOVA FCSH). Professor NOVA FCSH and researcher at the Interdisciplinary Center for Social Sciences (CICS.NOVA). Currently, Coordinator of the Department of Geography and Regional Planning and previously Coordinator of the Bachelor in Geography and Regional Planning from 2021 to 2023. Scientific interests broadly include urban studies, emphasising housing policies, real estate market, urban policies, urban geography and territorial planning. Author of 3 books, including "Políticas de habitação 200 anos" e "Direitos Humanos e Habitação: evolução do direito à habitação em Portugal". Coordinator of the scientific project "Impact of the COVID-19 pandemic on the Portuguese housing market" (HOUSING&COVID), funded by the Foundation for Science and

#### Inês Lobo

Has been researching several topics related with architectural education and practice, from the history of Portuguese architectural education to the morphology of urban and public space in Portugal, since the Expo'98 in Lisbon. He has worked from 1994 to 2012 with, (i) Duarte Cabral de Mello and Maria Manuel Godinho in the Public Spaces of Vila Expo'98 in Lisbon and, with (ii) Manuel Salgado at atelier Risco, in interventions like the FC Porto urban plan and stadium (Milan Triennale 2004), Cacém Polis (VII Ibero-American Biennale of Architecture and Urbanism, 2010), Portas do Mar in Ponta Delgada (National Tourism Prize 2009), Avenida do Mar in Funchal; Port of Horta Maritime Terminal (Habitar Portugal 2012-2014) or the Central Axis of Alto do Lumiar urban plan in Lisbon (construction is underway). These works have been published in Portugal and abroad. More recently he designed with Bernardo Miranda and an Iscte-iul team the new research building (CVVT-Iscte) and a number of future university residences in the Lisbon area.



### Ricardo Agarez

Ricardo Costa Agarez is an architect and architectural historian, specialised in the history and theory of 19th- and 20th-century cities and buildings, national and regional identities, knowledge dissemination and circulation of forms, ideas and techniques, housing and public architecture and the architectural culture in bureaucracy. He is currently senior researcher at ISCTE - University Institute of Lisbon; PI of projects ReARQ.IB - Built Environment Knowledge for Resilient, Sustainable Communities: Understanding Everyday Modern Architecture and Urban Design in the Iberian Peninsula (1939-1985) [ERC Starting Grant] e ArchNeed - The Architecture of Need: Community Facilities in Portugal 1945-1985 {FCT IC&-DT]; and co-editor-in-chief of ABE Journal - Architecture Beyond Europe. His PhD dissertation (The Bartlett School of Architecture, University College London) was awarded the RIBA President's Award for Research in 2013. The Giles Worsley Fellow of the British School at Rome (British Academy) in 2014, he was FWO Pegasus Marie Curie Postdoctoral Fellow at Ghent University in 2015 and, in 2016-2017, postdoctoral research fellow at KU Leuven.





### Sandra Marques Pereira

PhD in Sociology from ISCTE. Researcher at ISCTE, DINÂ-MIA'CET, where she is a member of the research group Cities and Territories, and the Sociodigital Lab for Public Policy. Guest lecturer at the Department of Architecture and Urbanism at ISCTE between 2011 and 2023, where she taught, among others, the course of Society and Architecture in the Integrated Master of Architecture. Lecturer of the subject Housing and Ways of Living in the Master of Urban Studies at FCSH-UNL/ISCTE. Has participated in several FCT research projects, including a project on residential trajectories in LMA and the projects on mass housing. Currently, co-coordinator of the Southern European Housing Working Group of the European Network for Housing Research, coordinator of the LxHabidata platform and Principal Researcher of the FCT-funded project SIZA 3CITY "Collective housing by Álvaro Siza: projects, contexts and experiences (Porto-Lisbon-New York)". Has several publications, national and international, of which the book "House and Social Change: a reading of Portuguese society through the house" stands out.



### Sérgio Antunes

Sérgio Antunes (Lisbon, 1977) is an architect, graduated from the Universidade Lusíada de Lisboa and the Università della Svizzera Italiana - Accademia di Architettura, Mendrisio (2003). He worked at Helena Botelho's studio from 2001 to 2004. In 2003, he co-founded the collective Kaputt!, where he participated in and coordinated various architecture, equipment design, graphic design, and installation projects. In 2010, he co-founded 18:25 Digital Contractors together with Luca Martinucci, a laboratory focused on constructing architectural imagery. Also, in 2010, he co-founded Aurora Arquitectos with Sofia Couto, a studio that remains active to this day. He has represented the various organizations he has been a part of in conferences, seminars, and workshops. His works have been exhibited and published in various national and international exhibitions and publications. He was a guest lecturer at the University of Western Australia - Lisbon Summer Studio in 2019, 2020, and 2023, and he currently serves as an invited Assistant Professor at ISCTE - IUL. Furthermore, Sérgio Antunes between 2020-2023 was Vice-President of the Regional Board of Lisbon and Vale do Tejo of the Association of Architects.

#### Tim Benton

Tim Benton is Professor Emeritus of Art History at the Open University. In 2008 he was visiting Professor in the Department of Art History and Archaeology, Columbia University. In 2009 he was the Robert Sterling Clark Visiting Professor of Art History at Williams College, Massachussetts. From 2010, he was visiting Professor at the Ecole Polytechnique Fédérale de Lausanne. His research interests include Le Corbusier's work of the 1920s and 1930s and the history of modern architecture and design. For several years he has been working on Le Corbusier's domestic architectural designs (1914-1935) which includes a study of all the architectural drawings and documents associated with these projects. He has developed computer software for the analysis of architectural drawings as part of this research. He contributed to two major exhibitions at the V&A: Art Deco 1910-1939 (2003) and Modernism Designing a new world (2006) and to the first major retrospective exhibition of the work of Charlotte Perriand at the Pompidou Centre, Paris (2006). Research into Le Corbusier's photography led to his contribution of a room to the exhibition 'Construire l'image: Le Corbusier et la photographie' at the Musée des Beaux Arts, La Chaux-de-Fonds, with a chapter in the catalogue and, a year later, a single-authored book. In 2014 he contributed a room on Le Corbusier and the Mediterranean to the exhibition Domus Mare Nostrum at the Hôtel des Arts de Toulon, with a chapter in the catalogue. He is preparing an exhibition on Art Deco at the Fondation March, Madrid, 2015. He has also worked on Italian architecture and design in the 1920s and 1930s.
