#### Corinne Larrue, Ecole d'Urbanisme de Paris

## The Grounding Processes of Socio-Ecological Transitions: From Experimentation to Institutionalisation

The presentation will highlight the processes through which socio-ecological transitions are grounded, as well as the tensions these transitions produce. Starting with an examination of territorialisation processes in the context of socio-ecological transitions over the past 50 years, it will consider these processes within various geographical and sectoral contexts. It will emphasise the variety of these processes, which can be either top-down, implementing frameworks and techniques defined at the European or national level, or based on highly localised experiments. The focus will then shift to the hybridisation processes that accompany the sustainability of socio-environmental transitions. Finally, it will consider the conditions under which experiments implemented in various fields of socio-ecological transition can influence institutional processes, focusing on urban planning and urbanism. The presentation will be based on case studies conducted in France, Europe and Quebec, focusing on areas highlighted in the call for proposals, such as: Biodiversity, energy, food production, mobility, the built environment and living spaces, and spatial and environmental justice. Finally, the consequences for public policy will be discussed.

Corinne Larrue has been a professor of urban planning and development at the University of Paris Est Créteil – Paris School of Urban Planning (EUP) and Lab'Urba since 2013, becoming professor emeritus in 2023. She previously taught at the University of Tours for around 20 years. She specialises in the analysis of environmental and land use policies, and her teaching and research focus on this area. She has contributed to the development of a coherent framework for analysing public policies based on the study of various environmental policies in France and Europe. She has participated in various European research programmes focusing on the comparative analysis of public environmental policies, and has published numerous articles and academic works reporting on this work.

## Maria Kaika, University of Amsterdam

# Urban Political Ecology for a Climate emergency: from scientific insight to radical imaginaries and prefigurative politics.

In this talk I argue that Urban Political Ecology's (UPE) ontologies, epistemologies, and methods are not simply an academic exercise; they are scientific developments that make academic research more relevant to the politics of climate change. Urban political ecology unsettles 'traditional' understandings of 'cities' as ontological entities separate from 'nature', and develops methods to examine how urbanization is inseparably and metabolically interlinked with flows of capital, labour, and resources, and with the metabolism of the entire biophysical world. I propose ways forward, to replace the currently dominant catastrophism over climate, with new forms of prefigurative and spatial politics and socio-political action for 'impossible' solutions. I draw upon the book: *Turning Up the Heat: Urban Political Ecology for a Climate Emergency* (Kaika, Keil, Mandler and Tzaninis (eds), 2023; Manchester University Press).

*Maria Kaika* holds a PhD from the University of Oxford and an MSc in Architecture and Planning from the National Technical University of Athens. She has taught at the Universities of Oxford, Manchester, Paris LATTS, TU Vienna, and KU Leuven. She holds the Chair in Urban Regional and Environmental Planning at the University of Amsterdam. She is recipient of the European Award of Excellence in Teaching in the Humanities and Social Sciences, and of the Jim Lews Prize for the most innovate academic publication (with L Ruggiero). Her research focuses on urban political ecology, the embodied politics of financialization, the relation between economic crisis and environmental and housing marginalization.

## Barbara Pizzo, Sapienza Università di Roma

### Post-Growth Planning: an oxymoron?

Post-growth thinking is spreading rather quickly in academic and public discourse, most commonly in relation to other concepts such as green transition or circular economy. This is hardly surprising, since it follows a common trajectory of new concepts, particularly for potentially unsettling ones, which get incorporated into the dominant views, thus becoming neutralized. When confronted with dominant development models, post-growth exposes fundamental contradictions within planning culture, institutions and tools, which remain structurally wedded to growth and expansion. Taking post-growth seriously implies a paradigm shift and radically challenges planning theories and practice. We will delve into post-growth from a critical planning perspective to understand what it is and what it is not. We will examine what conditions enable post-growth to be transformative and what obstacles impede that shift.

Barbara Pizzo, Ph.D., educated as an Architect and Planner, is Associate Professor in Urban Planning at Sapienza University of Rome, where she is a member of the interdisciplinary Ph.D. Program in Urban and Regional Studies. She has been Visiting Professor at TU Wien (2018) and at Ben Gurion University (2016) and a Visiting Scholar at several prestigious universities in Europe. She is a founding member of the "Winter School on Research Methodology", a network of Italian scholars in the fields of Planning and Urban Studies, interested in epistemological and methodological issues as topics of both research and education. She investigates socio-spatial configurations and changes, their driving factors and forces, with an orientation toward both planning theory and practice, focusing particularly on different interpretations of values and the related conflicts over land use, heritage, and the built environment. Her current research addresses urban rent dynamics in the context of rentier capitalism and financialization, as well as post-growth urbanism, examining planning challenges related to the crisis of development paradigms. She puts planning issues in dialogue with political economy and political ecology, working mainly in interdisciplinary research groups, so that keeping together the "How" and the "Why" of urban and territorial transformations has progressively become a distinct feature of her research and teaching approach.
